Mykola Nazarov's chapter specifically investigates National Resilience and Post-war Reconstruction, emphasizing that social stability—the ability of communities to return to a state of equilibrium—is the foundation for recovery. This section concludes with a look at the far-reaching global impact of Ukraine's reconstruction, which is seen as an opportunity to reshape the geopolitical and economic landscape of Eurasia and potentially rewire pathways of world commerce.

#### Part II: Economic, Development, and Digitalization Strategies

A major segment of the book is dedicated to the economic dimensions of recovery and reform. Antonia Colibășanu provides a "First Look at the Geoeconomic Challenges of Rebuilding Ukraine," noting that Western support for Ukraine's resilience is an integral first phase of the reconstruction project. The book champions the adoption of Sustainable Development Goals (SDGs) as a roadmap for renovation, outlining steps for sustainable development until 2030, which includes prioritizing clean and resource-efficient practices. The post-war project is explicitly envisioned from a European perspective, where sustainability is paramount.

Digitalization emerges as a critical component, explored in chapters on "The Digital Battlefield" and "A Critical Infrastructure Protection Perspective". The authors propose recommendations to enhance Ukraine's resilience against Russian hybrid attacks, including shoring up critical infrastructure protection. This strategic focus on technology aligns with the goal of creating "growth points" based on communities to stimulate the entire state to recovery. Furthermore, the book includes a chapter on the "Transformation of Public Policy in Ukrainian Book Publishing," which is framed as a critical basis for resisting Russian cultural expansion during and after the war.

#### Part III: Legal, Environmental, and Sectoral Reforms

The volume dedicates substantial space to the necessary legal and environmental frameworks for post-war Ukraine. Several chapters dissect the complex issue of war compensation, including:

It also addresses the "Formation of Competencies for Managers of Sustainable Development in Ukraine", emphasizing the need for leadership development at the community level to drive the sustainable functioning of society.

Edited by Silviu Nate, it successfully integrates perspectives across politics, military, economics, law, and environmental science to produce a coherent and action-oriented "blueprint".
