**1**st International Scientific Researches Congress Humanity and Social Sciences was organized in Madrid, Espana on 19-22 May 2016 with the focus of humanity and social sciences which were sponsored by IBAD Journal of International Scientific Researches, Yildiz Technical University, Turkey and Autonoma de Madrid University, Espana. The conference was held in We are Chamartin Hotel at Madrid. I was really a pleasure to see Madrid which is a city consists of history, culture and arts.

The congress has been carried out at 7 different conference rooms with 8 different sessions. Totally 566 instructors performed their presentations during these sessions. The themes of the conference were concerned with international relations, economics, business, education, humanities, communication, labor relations, psychology, political sciences, cultural studies, sociology, finance, human resources, labor economics, history, law, philosophy and linguistics. The papers were presented in both Turkish and English.

The themes of congress were concerned with human science, economy, management, law, sociology, theology, communication, finance, international relationship, history and political science. The first day of the conference started with opening speeches by Hayrullah Kahya on 20th of May.

On 20th of May 2016 our study was presented by Nazlı Arık who is a research assistant at the department of business of Gumushane University. The subject of our study is “Technological Awareness and Future Expectations of University Students: Empirical study”.

The survey in our paper was created considering literature and consists of three parts. Part one is including questions about demographics such as gender, age, education and income level. Part two includes questions measuring technology

awareness level and part three includes questions about future prospects. At the empirical application stage of this study, the multivariate analysis of variance (MANOVA) method has been used to analyze the data. The relationship between the variables of the model has been investigated by using the multiple regression analysis method. The results of this study conclude that there are significant differences on the technology awareness and future prospects arising from some of the demographical variables. The results also show that the relationship between the technology awareness and future prospects is significant.
